H15	Ensure access to and availability of, a wide range of foods for a healthy diet <i>(cont)</i>	<p>Fresh fruit and vegetables</p> <p>Eating more fresh fruit and vegetables is associated with a lower risk of coronary heart disease and stroke.^a</p> <p>There are no controlled intervention studies of the effects of eating more fruit and vegetables, so the size and nature of any real effect remains uncertain.^b The associations reported could be due to the fact that socioeconomic status is associated with both diet and risk of cardiovascular disease.^c</p> <p>Saturated fats and fatty acids</p> <p>Diets high in saturated fats and cholesterol increase blood cholesterol and the risk of coronary heart disease.^d</p> <p>Reduction in saturated dietary fat is associated with reduction in cardiovascular events if sustained for at least two years.^e</p> <p>Available evidence suggests that consumption of oily fish – rich in omega-3 fatty acids - is associated with reduced mortality from coronary heart disease in high risk groups, but not in low risk groups.^f</p> <p>Fish oil supplements or advice to eat more fish in coronary heart disease patients reduces mortality.^g</p> <p>Vitamins</p> <p>There is no evidence that beta-carotene^h and vitamin Eⁱ supplements affect cardiovascular disease.</p> <p>A review of the effects of antioxidant vitamins for coronary heart disease prevention is in preparation.^j</p> <p>While changes in diet are feasible in controlled settings in the short term and can result in reductions in cardiovascular risk factors,^d changing diets of free-living individuals through counselling and education is rarely possible.^k</p>	<ul style="list-style-type: none">a. Households in the lower end of income distribution spend a greater proportion of their income on food than those at the top. Low income restricts both the ability to afford many healthy foods and access to food retailers where healthy food can be purchased more cheaply.¹</p> <p>Adverse dietary patterns are reinforced by poverty as pricing policy encourages purchase and consumption of cholesterol-raising diets.
